### **SBA DISASTER LOAN DEADLINE IS JUNE 22; THERE IS STILL TIME TO APPLY**

**ATLANTA** - The U.S. Small Business Administration is reminding disaster victims that **June 22** is the filing deadline for federal economic injury disaster loans available in declared counties of Clinton, Essex, Rensselaer and Washington in the State of New York. The SBA declared a disaster because of damages and losses to crops caused by severe weather events including excessive rain, flooding, flash flooding, high winds, hail, lightning, and tornadoes that occurred from June 1, 2008 through August 31, 2008.

“These counties are eligible because they are contiguous to one or more primary counties in the State of Vermont. The SBA recognizes that disasters do not usually stop at county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included,” said Frank Skaggs, Director of SBA’s Field Operations Center East.

“When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to assist small businesses and most private, non-profit organizations affected by the same disaster,” Skaggs added.

Under this declaration, the SBA’s Economic Injury Disaster Loan program is available to farm-related and nonfarm-related small business concerns, small agricultural cooperatives and most private, non-profit organizations of all sizes that suffered financial losses as a direct result of this disaster. Farmers and ranchers are not eligible to apply to SBA.

Eligible small businesses and non-profit organizations may qualify for loans up to \$2 million. These loans are available at a 4 percent interest rate with loan terms up to 30 years. The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Loan amounts and terms are set by the SBA and are based on each applicant’s financial condition. Under this disaster declaration, the SBA cannot provide loans to agricultural producers.
