SBA DISASTER LOAN DEADLINE IN INDIANA IS AUGUST 31 *SMALL BUSINESS OWNERS STILL HAVE TIME TO APPLY*

ATLANTA - The U.S. Small Business Administration is reminding small businesses that **August 31** is the filing deadline for federal economic injury disaster loans that are available in the counties of Elkhart, LaPorte, LaGrange and Saint Joseph in the State of Indiana as a result of several frost/freeze and cold weather events that occurred from March 1, 2008 through May 31, 2008.

“These counties are eligible because they are contiguous to one or more primary counties in the State of Michigan. SBA recognizes that disasters do not usually stop at the county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included,” said Frank Skaggs, Director of SBA’s Field Operations Center East.

“When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to assist small businesses, small agricultural cooperatives and most private, non-profit organizations of all sizes affected by the same disaster,” Skaggs added.

Under this declaration, SBA’s Economic Injury Disaster Loan (EIDL) program is available to farm-related and nonfarm-related small business concerns, small agricultural cooperatives and most private, non-profit organizations of all sizes that suffered financial losses as a direct result of this disaster. Farmers and ranchers are not eligible to apply to SBA.

Eligible small businesses and non-profit organizations may qualify for loans up to \$2 million. These loans are available at a 4 percent interest rate with loan terms up to 30 years. SBA determines eligibility for the program based on the size of the applicant, type of activity and its financial resources. Loan amounts and terms are set by SBA and are based on each applicant’s financial condition. Under this disaster declaration, SBA cannot provide loans to agricultural producers.
